- 2. Planning of international placements (Learning Agreement) For each specific mobility it is necessary to settle a more detailed individual agreement. Between the home and the host institution, and the individual student has to be agreed what will be learnt abroad and how these learning outcomes will be integrated into the student's qualifications.
- 3. Learning units as part of a qualification (description of Learning Units) The learning outcomes that the students can achieve during their mobility abroad have to be described clearly in terms of Knowledge, Skills and Competences. Attention should be paid to the fact that the student might participate in learning activities that go beyond the learning outcomes acquired in the home country. How to describe these learning units is subject of this workshop.
- 4. Assessment and transfer of credits and results (Assessment Forms) Once the learning process is completed, the student must demonstrate the achievement of the required learning outcomes. For this assessment several forms can be applied: standardised assessment grids, written statements by the assessor, the use of grades etc.

The workshops will be moderated by members of the development group of the Your ECVET project. Recommendations, template documents and a user's advice will be presented and discussed. Participants in the workshops will get the tools to start using ECVET in their own institute.
