DESCRIPTION: At present, the automotive industry is under great pressure because of energy and environmental issues: greenhouse gas accumulation, air quality, security of energy supply. Forced by these problems, car manufacturers will restyle the car drive train concept towards alternative fuels, hybrid systems, fuel cell technology, ...

For some years now, there is a real ICT revolution in the automotive world: comfort-electronics, security electronics, the engine control unit and the communication between those, bring more complexity into the vehicle.

However, in many EU countries, a university degree in automotive engineering does not exist, as automotive education is often only offered as a two or three year professional bachelor education. Moreover, only a few universities offer this kind of education. Companies have problems to fill their demands with master-level automotive engineers.

'CarEcology' is designed to fill up this gap. By combining the expertise of several institutions with an extensive experience in automotive research, a European programme of 60 ECTS credits will be developed and delivered as a full second degree single programme for master engineering students. Focus will be on present-day energy and environmental issues and trends in vehicle electronics.

Both student and teaching mobility will be integrated in the curriculum.

TITLE:	4CITES - UNICA EUROMASTER IN URBAN STUDIES

DESCRIPTION: The objective is to develop a UNICA EUROMASTER in URBAN STUDIES. The Universities of Brussels (VUB & ULB), Vienna, Copenhagen and Madrid (Complutense & Autónoma) will set up a two year joint-master programme in co-operation with UNICA (Network of Universities of the Capitals of Europe).
The network will develop a high-standing and strongly integrated international master programme in urban studies with a focus on European Cities. The target group consists of master students with bachelor degree. The Euromaster is built around an integrated set of modules organised by each of the partners. Students will follow these modules in a compulsory sequence in the four participating cities. Each module consists of several academic courses in combination with field work and excursions. At the end of the 2 year programme students will have a profound knowledge on globalisation, urbanism and the dynamics of European cities, and will have learned several practical skills which will be of use in their working experience. The students will be prepared to an employment on an international or European labour market.
For this to realise we have to further develop the curriculum, set up a management structure for the course, develop quality control and a marketing strategy and solve accreditation problems (joint master).

TITLE: Advanced level study programme in Electronic Design and Integration Technologies

DESCRIPTION: To stay a competitive region in the world, combined efforts towards sharing expertise in the field of advanced electronic design (analogue and RF design, digital data processing) and advanced integration technologies is becoming a necessity. Master students in electronics and related fields are confronted with an international working area. To incorporate this facet during their last year of studies will broaden their opportunities and language skills. Synergy between the participating institutes and the joint effort to develop a common programme, will allow the consortium to deal with the fast changing methodologies in electronic design and related fields. Infrastructure costs to support the teaching of certain advanced modules are considerable and European Programmes such as Europractice provide support on design tools and access towards integration technologies e.g. CMOS, BICMOS.

The proposed programme to be realised at each university institute will be based on the following structure: home specific basic and advanced modules, remote introductory and advanced modules. Target group for the programme are bachelor students + 60 ECTS who have to select at least 10 credits from a partner institute. One partner in the consortium, who provides continuous education, will ensure that already working graduated engineers can update or expand their technological skills. Assessment of the remote modules which are available for all students in the consortium and for external students will be done by each partner institute and a common procedure on the assessment method will be established. Certification for the remote modules will be done from year 2 on by each partner institute and the path for providing a common degree will be decided during year 3.

According to the expertise and research skills of the staff, each institute will provide and support the possibility for a diploma project in close cooperation with industry for incoming students on mobility.

DESCRIPTION: **OBJECTIVES:**
To develop a clear-cut curriculum at doctoral level in musical arts. In preparation for this, to draw upon the combined strengths of university- and conservatoire-based collaborators in formulating a conceptual framework for a practice-based music doctorate. Based upon this framework, to develop and implement through international collaboration the first joint European doctoral degree programme devoted to practice-as-research in music.

TARGET GROUPS:

- a) European and international institutions wishing to develop doctoral programmes in musical arts. These may be conservatoires wishing to expand their activities into the third cycle or universities interested in the burgeoning field of performance studies.
- b) Students currently in first- or second-cycle training who wish to continue their studies to third-cycle level whilst maintaining a strong practical strand to their work.
- c) Staff involved in enacting the innovations which the new curriculum requires.

MAIN ACTIVITIES:

Developing a conceptual framework;
devising a curriculum;
designing the appropriate organisational structures;
piloting the curriculum in at least three institutions.

A clear definition of practice-as-research as it applies to music;
a doctoral curriculum for the musical arts embodying this definition;
successful piloting of this curriculum, leading to the awarding of the first European joint doctoral degrees in the musical arts.

TITLE:	Joint Degree in Media Development Engineering

DESCRIPTION: The project aims to develop a Joint Degree in Media Development Engineering at undergraduate level. The study programme will run simultaneously in six educational institutions across Europe. The goal is to develop a standardised study programme which will eliminate the differences in level and contents that actually exist in each participating country. The contents will be developed on the basis of Active Learning with support of online modules. The study programme will be developed in concordance with the Bologna Process (ECTS and Diploma Supplement).
The studies will be based on a combination of study programmes that are already running in the participating institutions. The project will take advantage of local expertise by offering a unique specialisation at each participating institution that the students will follow at the country of their choice in the final year.
By including 'soft subjects' in the Artistic Module, the education intends to attract more female students to the engineering studies. At the end of the studies, the graduates will receive a Bachelor of Science Joint Degree signed and recognised by all the participating institutions.
By its composition, the study programme promotes student and staff mobility. Dissemination will allow for further expansion of the network.

Die Globalisierung der Arbeitswelt erfordert von allen Bildungsinstitutionen, der Internationalisierung der Ausbildung einen größeren Stellenwert einzuräumen. TITLE:	EUMASLI: European Master in Sign Language Interpreting

DESCRIPTION: The project aims at developing and establishing a joint European Master degree programme that qualifies participants for research, development, and management functions in the area of sign language interpreting in their respective countries. The programme is thus intended to contribute to the development of the professional field of interpreting between deaf and hearing people in Europe.

The Master programme will be offered on a part-time basis including elements of blended learning. Participants will gain 60 ECTS-credit points over a period of 2.5 years. Participants will be expected to have a first degree as well as professional experience as sign language interpreters. Participation in the programme will include learning experience in all of the three participating countries.

The programme is to be developed and implemented by the three participating universities on the basis of previous experience with the academic training of sign language interpreters. It draws upon the strength of a long-standing European partnership, bringing together differing traditions in the development of professional sign language interpreting in Europe. The programme is meant to set an example and to be extended to other European countries where academic training of sign language interpreters is yet to be established.
