Erasmus University Charter (EUC) Brussels, January 2007

- Higher Education Institutions (HEI) must be awarded the EUC under the LLP to be a coordinator of an Erasmus Multilateral project or a Network.
- Submission deadline: 28 February 2007
- Submission procedure*: electronic on-line submission + signed paper copy

Assessment procedure

- Brussels, January 2007
- Eligibility and financial aspects are checked by the Executive Agency staff
- Each application (award criteria) is assessed by 2 independent external experts
- The panel of experts proposes a "short list" of applications for a Community cofinancing
- Based on the experts "recommendations", the Commission takes the final decision on selected projects

Get the application form from the web site

Fill in the application form (not yet available) and observe the financial rulesArrange signature by the legal representative of the applicant institution

Step 3: Submission of the application

Send the full application (1 original + 3 copies + an electronic version) by mail by 30 March 2007 (postmark) and (30 April 2007) for Accompanying Measures) to the Executive Agency.

Curriculum Development

Objectives

To reinforce the quality and the European dimension of higher education teaching by combining the expertise and state-of-the-art knowledge of Higher Education Institution from several countries. Particular importance is attached to co-operation with the professional world and the world of enterprise







Priorities

- Developing or revising integrated programmes covering a complete cycle of study (bachelor, master and doctorate) and leading to a recognised double or joint degree
- Implementing the integrated programme in the partner institutions in the academic year following the end of the projects (enrolment of first students)
- Developing curricula which actively promote multilingualism, linguistic diversity, Interculturalism in European society
- Developing curricula for continuing education addressing the needs of updating knowledge obtained in the past at undergraduate or postgraduates studies.

Activities supported

- Projects for the joint development of "study programmes" at first, second or third (bachelor, master, or doctoral) level
- Projects for the joint development of European
 "modules", including specialised language modules

Two steps project execution

Development phase

Joint development of study programmes Joint development of European modules

Implementation and dissemination phase The last year covered by the grant should be the first year of implementation by the partner institutions

Implementation and dissemination (examples):

- tutoring and guidance
- quality assurance mechanisms

- enlargement of the network of partners
- expansion of the project into sectors like further and adult education
- degree awarding
- promotion of the project among possible employers of graduates

Objectives

Facilitation and intensification of cooperation between Higher Education Institutions (HEI) and enterprises by creating a common culture and understanding and developing exemplary actions in this area.







Priorities

- Developing strategies for cooperation between higher education and enterprises which has to include a clear concept of guidance and counselling;
- ➤ Introduce entrepreneurship as part of the curriculum for students and especially as a skill for teachers/researchers;
- Including small and medium-sized enterprises as well as professional organisations, chambers of commerce, social partners and local/regional bodies;
- Transferring innovations from vocational education and training (VET) to the academic domain of higher education (HE) and vice-versa;
- Stimulating cooperation between regions and economic sectors with little history of cross-border contacts;
- Reinforcing both economic development and social cohesion.




Objectives




Priorities

- Focus on issues relating to access to higher education
- Address the "knowledge triangle" of education, research and innovation
- Address issues relating to governance and diversification of higher education institutions
- Link general higher education, advanced vocational education and training with the world of work
- Map and update the state of the art in their field and explore ways to foster more European cooperation



Lifelong Learning Programme



- Define and update generic and subject-specific competences using the same method as the pilot project "Tuning Educational Structures in Europe"
- Develop standards for quality assurance in their particular field, taking into account the quality references and guidelines adopted in Bergen in May 2005 (Bologna Process)
- Address subject areas which are not yet addressed so far by projects in this field of action, such as economics, literature, philosophy, mathematics and the cultural dimension of education
- Map and check "rare knowledge" in any given discipline or transversal subject by compiling a list of disappearing teaching methods and concepts







Activities

<u>Examples</u>:

- Describing, analysing, and comparing existing teaching methods
- Identifying existing teaching material and placing this at the disposal of the members of the network with the aid of databases
- Setting up tools (the use of ECTS, new models of co-ordination etc.)
- Promoting the production of European modules
