SCHOLARSHIPS of MONTENEGRO
for short-term individual studies in the academic year 2014/2015

OPEN CALL

Deadline for applications: April 30th, 2014

The Government of Montenegro hereby announces a limited number of scholarships for the academic year 2014/15 (from 8. 09. 2014 until 30. 09. 2015) on the basis of bilateral agreement in the field of education with Slovenia.

The scholarships are open to Slovenian students who wish to come to Montenegro as an exchange student. The main purpose of the scholarship scheme is to support Slovenian students who wish to undertake **a part of their** study (undergraduate or postgraduate) on the **individual basis** under the supervision of Montenegrin lecturer.

CONDITIONS:

- **STUDY PERIOD**

The duration of an individual scholarship can be up to 6 months. Minimum duration is 3 months.

- **FIELDS OF STUDY**

The scholarship can be awarded for any field of study offered by the Montenegrin higher education institutions.

- **STUDENT STATUS**

The applicant must be enrolled at the higher institution in Slovenia and come to Montenegro as an exchange student.

Scholarships are not complementary: students can have only one scholarship, regardless of its source.

- **INSTITUTIONAL CONTACTS**

The scholarship can only be awarded if the Letter of acceptance addressed to the applicants name from the Montenegrin higher education institution and Study confirmation addressed to the applicants name from the home higher education institution have been enclosed to the application

- **STUDY LEVEL**

The scholarship cannot be awarded for a complete course of study leading to a degree.

- **LANGUAGE OF INSTRUCTION**

The candidates should speak Montenegrin or the working language agreed upon with the mentor/supervisor.

- **SCHOLARSHIP**

The scholarship covers:

- accommodation and board paid for by the Ministry of Education directly;
- basic medical insurance for time being in Montenegro as an exchange student if there is no bilateral agreement on health insurance between Montenegro and Slovenia;
- 100 EUR monthly subsistence.

- **SUBMISSION OF THE APPLICATION**

The candidate should address themselves to the authorities of their country that are competent to collect the application and to select and recommend candidates.

Individual applications sent to the Ministry of Education of Montenegro are not eligible.

The list of nominated candidates of the competent authority of Slovenia, together with complete application form in **three (3) copies (one original and 2 copies)** with accompanying annexes have to be sent to the Ministry of Education of Montenegro.
